

- 2) The facility shall provide the mechanism to get the purge water from scrubber to MEE within one month and thereafter, submit the compliance to the O/o Environmental Engineer, Punjab Pollution Control Board, Regional Office, SAS Nagar within 3-days.
- 3) The facility shall submit an undertaking to the effect that it shall not lift hazardous waste from any industry/ project/ warehouse who does not have valid authorization of the Board as required under the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 and shall also obtain requisite permission from the Board if hazardous waste is to be lifted from other State.


